I, Danna Vale, Minister for Veterans' Affairs:

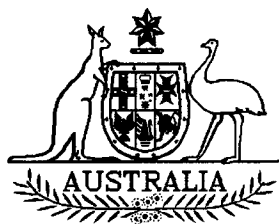
