



Instrument for Determining Eligibility under the Veterans' Entitlements Act 1986

Singapore 29 June 1950 to 31 August 1957

1. This instrument is issued by the Defence Force under subsection 6D(1) of the *Veterans' Entitlements Act 1986* ("the Act") for use by the Repatriation Commission in determining a person's eligibility for entitlements under the Act.
2. The instrument for determining eligibility under the Act that was made by C.A. Barrie Vice Admiral, AM, RAN Vice Chief of the Defence Force on 3 June 1998 in relation to units or parts of units of the Defence Force that were assigned for service in Singapore at any time during the period from and including 29 June 1950 to and including 31 August 1957 is revoked with effect from 1 January 2001 and is not to be taken to have any legal effect or operation in relation to the making of any decision under the Act on or after 1 January 2001.
3. Each unit of the Defence Force identified in column 1 of the Schedule to this instrument was assigned for service in Singapore between and including the dates set out opposite that unit in column 2.
